Perry State Park is now pleased to offer cabin rentals at our park. You as one of our patrons can enjoy the option to rent one of these cabins. Treat it with respect; follow all the rules, regulations, and it will last for several years for you and others to enjoy. Beds are fitted with mattresses only, so **YOU WILL NEED TO BRING YOUR OWN BEDDING**. Your own toiletries, bedding, lawn chairs, and any other camping essentials you may need to make your stay a pleasurable one.

REGULATIONS

All mandatory Park regulations will apply to cabin rentals

1. No smoking inside the cabin
2. Vehicle Permits will be required
3. Pets must remain outside on a chain of 10 feet or less
4. Must be 18 years of age to rent the cabins
5. Please observe the quiet hours (11:00 p.m.-6 a.m.)

To ensure availability, reservations should be made at least 7 days prior to the planned arrival date. A damage deposit of \$100 is required upon arrival and must be issued on a separate check. At the discretion of park personnel, this deposit will be refunded if the cabin is left in good condition. Cabin renters shall be responsible for full payment of any damages incurred during their length of stay.

ABOUT REFUNDS AND CANCELLATIONS

The cabin reservation fee cannot be refunded, however if you notify the park office seven days prior to your reservation date, the remaining cabin reservation fee may be arranged and your fee applied to a new date.

Reservation applications are accepted by telephone, fax, mail, or in person and only accepted for the current year. All applications are handled on a first come first serve basis. Reservations by phone require payment by credit card. A reservation fee includes the total cabin rental fee and a \$10.50 nonrefundable reservation deposit.
