LOVEWELL STATE PARK 2019 ANNUAL PARK REPORT

I. Introduction. Lovewell Reservoir was built by the Bureau of Reclamation in 1957, for flood control and irrigation purposes. It is located in North Central Kansas, on the White Rock Creek. Lovewell State Park was established in 1967 on BOR property and is currently being leased by the State of Kansas, Department of Wildlife, Parks and Tourism, to provide outdoor recreational opportunities to the public. Constituent interests, recreational trends, environmental impacts and other concerns all have an influence on the park's future operations. The following annual park report is to be used as a tool to evaluate past and present operations, and as a guide for future goals.

II. Revenue and Visitation. (See Tables 1-2; Figures 1-3). Revenue for 2019 was relatively unchanged over 2018 figures, even though there were plenty of events which negatively affected visitation for this year. We were not able to avoid the historic flooding that plagued much of the state in the early park season, reaching its third highest ever elevation of 1593.0 in mid-July of this year. This caused the closing of several primitive camping areas throughout the state park, and discouraged visitors for most of May, June and early July. In late July, Lovewell Reservoir was placed in Watch and then Warning Status for harmful blue-green algae blooms, for a period of about 4 weeks. Other than the early torrential rains, the weather did not cause any major problems through the rest of the season. The usual irrigation drawdowns began in late July, and coupled with a planned maintenance repair to the dam structure, brought Lovewell Reservoir to its second lowest ever elevation of 1571.5 at the end of September, which negatively affected revenue and visitation at the end of the season.

Vehicle revenues were down 10% overall, however Daily Vehicle permit sales were down over 20%, probably due to the adverse lake conditions this year and a lack of day use for the season. Camping revenues were only down 2% overall from 2018, however significant increases in the cost of Seasonal Campsites this year served to mask the decrease in other camping revenues. One bright spot

was a 40% increase in the sale of the 14Day Camping Permit this year. Camping Cabin revenues were down 4%, and there was a slight drop in the revenues received from Online Sales. Special Event permit revenues were down nearly 30%, again most likely due to the lake conditions. Retail sales actually showed a slight upturn, although the offering of items is still very

dismal. Staff will continue to push for funding for new and desirable retail items for offering at the office location. Private Cabin Permit fees increased another 22% over 2018 with the annual increases set forth in the new Private Cabin Permit initiated in 2017. This section of revenue, coupled with the increase in Seasonal Campsite fees, is the only reason Lovewell State Park did

not have a significant drop in revenue this year. Revenues from penalties decreased nearly 50%, indicating good compliance with regard to vehicle permits and adherence to campsite checkout times, as well as the option of purchasing an Annual Vehicle permit to void the penalty.

Revenues for hunting, fishing and big game issuances decreased 14% overall. There were very few items that showed an increase: Kansas Senior Hunt/Fish licenses, Waterfowl Stamps, and Landowner/Tenant Deer permits, and the increases were only slight.

As a whole, revenues were divided as 13% in vehicle permit sales, 32% camping, 18% of income was attributed to online sales (non-field), 11% hunting/fishing licenses, 7% in camping cabin revenues and the remaining 19% in cabin leases, marina payment, boating, retail and miscellaneous receipts.

Although revenue figures can be deceiving, the visitation figures definitely tell the tale. Overall, there was a 17% decrease in visitation from 2018, and can be attributed entirely to adverse lake conditions throughout the season. Visitor demographic comparison of campsite and cabin stays changed slightly, with 66% of visitors from Nebraska, and 26% from Kansas. Visitors from thirty-eight other states and one Canadian province accounted for the remaining 8% of visitation this year. Lovewell State Park staff continually strives to attract new visitors through timely marketing efforts of the Spring Newsletter, local news releases and social media efforts, and personal contacts at the Omaha Boat Sport and Travel show.

III. Budget and Capital Improvements (See Table 3 and Figure 4). Lovewell's FY19 O&M budget was slightly increased from FY18. Staff was still cautioned to conserve 5% of the budget to offset shortfalls, and \$20,000 was held back as statewide cabin funds were utilized to pay several months of utility fees. As seen in Table 3, a significant amount of LOVP's O&M was not spent for this reason. Concerns over O&M budget insufficiencies continue to mount, as aging facilities begin to need more costly maintenance and repairs. A major increase in fees paid for water received from the Rural Water District continues to impact the budget and efforts to conserve water will continue to be enforced. Significant water leaks were sought out and repaired as soon as possible. Seasonal salary budget increased to \$38,000 for FY19, and a 40 hour seasonal maintenance position was hired which greatly benefitted the maintenance work accomplished throughout the state park. However there are still not enough funds for seasonal ranger support, and camp hosts are required to log an increased minimum number of volunteer hours in exchange for their campsite. Nearly constant use of the camping cabins during the peak months creates the need for dedicated staff for the cleaning and administration of camping cabins and check-ins/outs, requiring more from the seasonal budget for these duties. Considering the fact that park facilities are becoming more intensely used and additional facility maintenance is increasingly required, restoration of seasonal salary budgets will be needed to provide the necessary level of services for constituents. There were no Capital Outlay expenditures for Lovewell State Park in 2019, however Parks Division provided a new patrol vehicle for NRO Mocaby. An MBA Capital Improvement Project to build a rock jetty at Cedar Point Boat Ramp, was begun late in 2019 and will be completed in early 2020. This structure will serve to reduce the shoreline erosion in that area from boat wakes. A statewide Motor Boat Access grant was utilized to install a Life Jacket Loaner program kiosk at the Marina Boat Ramp, informing customers that life jackets can be borrowed for their use from the State Park Office. Statewide Cabin funds were designated for replacement of deteriorating exterior siding for the Frontier Camping Cabin, which was completed in early 2019. Parks Division funds were also secured to replace the deteriorating septic system at the Rose Hill Dump Station, which was completed in September of 2019. Thankfully, the flooding of 2019 did not negatively impact any structural facilities. Park staff will continue to seek out alternative funding opportunities, to include a recreational trail, campground improvements, and improvements to the four deluxe cabins to extend their seasonal feasibility, as the lack of insulation affects rental income in both the heat of summer and forced closure of the cabins for the winter months.

IV. Contracts. Aaron and Jana Coil served their fourth year as the marina concessionaires for Lovewell State Park. The marina continues to draw new and repeat visitors with their offering of weekend breakfast, short order sandwiches, homemade pizzas, and barbecue meal specials, and equipment rentals. Facilities are very well-maintained and no major problems occurred, with the exception of damages to docks from flooded coves. The 2019 Marina Concession Permit payment was received, in the amount of \$15,300. A vault toilet located at the marina area is an on-going issue with regard to maintenance, and will be evaluated in the future.


Lovewell State Park administers 60 private cabin permits. The current 5-year permit is in its third year, with the next advance of the fee at \$1500 for the year. There continues to be a number of information requests regarding what is and is not allowed with the new cabin permit. An amendment to the permit beginning in 2020 now allows construction of facilities on the cabin lots beyond the existing footprint, with written approval and within guidelines. All cabin owners remained in compliance with the new permit regulations for the year.


V. Manpower. Maintaining a sufficient level of permanent and seasonal salary funding is paramount in providing high-quality park operations. Lovewell State Park strives to maintain high quality permanent and seasonal staff, who consistently work to improve park operations. Lovewell State Park was fully staffed in 2019 with a full-time Park Manager, Park Ranger, Facilities Specialist, and Administrative Specialist. Law Enforcement duties were shared once again between the Park Manager and Park Ranger, but the lack of seasonal salary funding for a seasonal ranger left the park still without law enforcement coverage from midnight to 8 am on weekends. Fortunately, there were no major law enforcement incidences that occurred.

Dedicated seasonal camp hosts are vital to constituent service and are a very high priority in summer staff hiring. A set of camp hosts in each of the four utility campgrounds is most desired. Lovewell Staff is constantly recruiting potential camp hosts for this important part of our seasonal staffing. Camp hosts were hired and placed in three of the four of the utility campgrounds in 2019, however one of them suffered a broken ankle (off-duty) and their season was cut short. One set of parttime camp hosts were tasked with regular maintenance duties, in addition to assisting with special events. The other part-time camp hosts were assigned to trash collection and camping cabin maintenance, cleaning and check-in/out. A shift to more volunteer hours (vs payroll hours) was again utilized for the 2019 season in order to conserve seasonal salary funds, and seemed to work well. Two and a half seasonal office assistants completed the seasonal work force. Regular work schedules for seasonal maintenance and office positions began in late April. Weekend office hours for the seasonal office assistants were limited to Saturday/Sunday until Memorial Weekend, due to school hours. Office hours through the summer months were 8am to 6:00pm Sunday through Thursday, and 8am to 8:30pm on Fridays and Saturdays. Staff will continue to recruit AmeriCorps team members in the future. If none are found, this will continue to impact the future facility enhancement and productivity at Lovewell State Park. Lovewell staff members agree that the AmeriCorps program greatly benefits its park operations.


- VI. Ag Summary. Lovewell State Park initiated an ag contract in 2014, for haying of non-developed areas of the park. Brett Behrends was the ag permittee in 2019, and had one haying for revenue of \$688. Ag funds have been earmarked toward non-8220 equipment repairs.
- VII. Chemical Use. Minimal amounts of chemical were used for the purposes of controlling noxious weeds. Approximately 2 acres of spot spraying and campsite edges in all four utility campgrounds, using 2-4D and Banvel, were applied.
- VIII. Law Enforcement and Public Safety. (See Figure 5; Table 3a). The permanent law enforcement personnel consist of the Park Manager and Park Ranger. Numerous incidents ranging from attempt to locate, services rendered, theft investigation, vandalism, disorderly conduct, parties, mischievous behavior, moving vehicle violations, alcohol related violations and general concerns from constituents were recorded.

Lovewell State Park's law enforcement staff issued 17 NTA's. Multiple written and verbal warnings were also issued for numerous violations. Park staff collectively issued 55 yellow summonses. Of those summonses written, 22 were for camping, 33 were for vehicle.





With over 200,000 visitors at Lovewell State Park, thefts and vandalism is always a concern for park staff. Constituent safety and personal property is a high priority for park staff. Theft trends have continued to stay towards a low level. There were 3 reported thefts over the summer months. Over the past several years park LE staff has talked to constituents on securing their campsites to prevent thefts. There were a few minor incidents with vandalism this year, mainly to cabins and shower houses. Lovewell State Park staff takes pride in all the facilities and campgrounds within the park and vandalism is a high priority to parks law enforcement.



The law enforcement staff at Lovewell State Park has taken a "hands on" approach to enforcement with in the park. Our philosophy consists of maintaining a high visibility profile accompanied by numerous contacts with constituents in efforts to maximize public safety and involvement. This practice strengthens cooperation from our growing constituent visitors and is a

positive public relations tool. Working closely with our local sheriff's office, Highway Patrol, and surrounding law enforcement agencies has also been a major part of our operation. Staff was faced with numerous enforcement challenges ranging from boating, theft, park violations, domestic, traffic, alcohol violations, and natural resource-related issues. Lovewell's practice is to ensure that all users purchase required permits when applicable. The option to purchase annual permits after receiving a summons has proven to be a good tool for public relations and permit compliance.

The following is a list of enforcement efforts by Lovewell State Park officers. The incidents have been broken down into categories associated with our direct enforcement efforts.

- 1. Alcohol Cases: 4 alcohol case were identified.
- 2. Boating Cases: 2 boating case were identified.
- 3. Drug Cases: 1 drug cases were identified.
- 4. Park Cases: 55 yellow summonses were issued.
- 5. Property Cases: 3 case involving theft of property was investigated.
- 6. Traffic Cases: 9 moving violations were cited. Several verbal and written warnings were addressed to constituents.
- 7. Fish and Wildlife Cases: 0 cases were identified.
- 8. Accidents: 1 vehicle accident was investigated.
- 9. Park Regulations: 0 case was issued.

As Lovewell State Park grows in visitation, the overall Law Enforcement trends have relatively stayed the same. Thanks in part to the Jewell County Sheriff's officers and other law enforcement agencies for their assistance throughout the year! Multiple written and verbal warnings were given to park constituents throughout the summer months. Officers used discretion and education over issuing tickets for a majority of the patrol stops.

IX. Special Events and Activities (See Table 4). Lovewell State Park began the season with a Free Park Entrance Day on May 4th, which was a statewide event in conjunction with the Let's Camp America national campaign. Another statewide event, Kids to Parks Day, was held on Saturday, May 18th, with park staff hosting a Youth Archery Clinic. An Amphibian and Reptile Program, which had also been scheduled for that day and was to be presented by Fort Hays University staff, had to be cancelled due to an unforeseen family emergency for the University presenter. The Kids Fishing Clinic held on June 9th had 4 kids and several parents participating in sessions on proper casting, knot tying, bait/lure selection, fish identification, and fish cleaning. The Float Your Boat Contest was scheduled for Father's Day, June 16th, but had to be cancelled due to high water. The Annual Fireworks Display was held on Saturday July 6th, with approximately 2000 people viewing the display. Many, many favorable comments were received and members of the Lovewell Lake Fireworks Committee will continue to fundraise for this annual event. Lovewell Fun Day events on August 3rd had a new event added, a Scavenger Hunt throughout the State Park. This was very well received by those participating, and will continue as a part of the Fun Day in future years. CoEd Mud Volleyball Tournament had 8 teams, and the Sand Pile Treasure Hunt had 26 kids participating. Another event on Fun Day, a Cornhole Tournament, was added by the Lovewell Lake Fireworks Committee as a fundraiser for the annual fireworks show. It had 16 teams registered. The Campground Christmas event, also in August, only had 9 decorated campsites. The declining registration for this event over the last several years may result in it being deleted from the special events for the year. However, this event does bring many observers to the park to view the decorations. The 3-D Archery tournament was held September 8th but only had 8 participants this year. Staff was informed that there was another major tournament in

the area that same day, and may have been the cause for the decline in participation this year. This was designated as Lovewell State Park's Free Park Entrance Day as well. Other events included family campouts, picnics and reunions, company picnics, birthdays and anniversaries, weddings, memorial services, church group outings, and high school reunions. Non-denominational church services were held each weekend from Memorial Day thru Labor Day.

X. Reservoir Water Levels. (See Figure 6). Lovewell Reservoir levels are maintained by the BOR and Kansas Bostwick Irrigation District. Lovewell Reservoir began the year 4 ½ feet below conservation pool at 1578.1. Steady inflows from the Republican River Diversion brought the reservoir level to conservation pool level by the end of April. Unfortunately, heavy rain events began in May, and much like many other reservoirs in Kansas, Lovewell Reservoir was near the top of flood pool for most of June and July. In fact, Lovewell Reservoir reached its second highest elevation ever in late June. Releases were finally able to initiated in mid- July. Significant releases continued throughout August and September, to facilitate a planned repair project to the dam gates and structure. Lovewell Reservoir reached its second lowest elevation recorded in late September, at 1570.0. Significant inflows from the Republican River Diversion brought the reservoir back to conservation pool by the end of December.

XI. **Conclusion.** Lovewell State Park definitely suffered this year at the hands of Mother Nature and events outside of our control. Historic flooding diminished campsite occupancy and day use in May, June and early July, as well as causing significant damage and cleanup to shoreline facilities and vegetation. A bout with harmful blue-green algae bloom immediately followed. Historic drawdowns for a scheduled dam repair also affected campsite occupancy and day use in the later summer months to finish out the season. Lovewell State Park staff continually work to make the best of every situation that occurs, work to provide the best experiences and facilities possible, and look hopefully to the future. The drop in visitation and license sales (offset by the increased private cabin and seasonal site fees), is obviously concerning, but staff is confident that old and new constituents will return to the park each coming year, as 2019 was definitely not usual and surely won't be repeated. Availability of budget funds available will continue to affect the staff's ability to maintain the park and its facilities at the high standard that visitors are accustomed to. However, quality outdoor recreation for our constituents will again remain the highest priority to the Lovewell State Park staff. Many significant accomplishments were achieved in 2019, and many more are planned for 2020. (See Table 5). Our personnel will continue to work toward providing the best facilities and customer service that manpower and funding will allow.





LOVP 2019 SELF PAY VS. OFFICE SALES






