ERO No. 48

This Executive Reorganization Order would relocate the state's Tourism Division to the Kansas Department of Commerce, and designate the Kansas Department of Wildlife, Parks and Tourism as the Kansas Department of Wildlife and Parks.

This ERO was submitted by Governor Laura Kelly to the Kansas Legislature on Jan. 25, 2021. This ERO becomes effective on July 1, 2021, following its transmittal to the Legislature, unless within 60 calendar days of

transmittal, either the Senate or House adopts a resolution disapproving it.

HB2025

This bill would prohibit KDWPT law enforcement officers from conducting physical or electronic surveillance on private property without a warrant.

This bill was prefiled on Dec. 31, 2020, and introduced on Jan. 11, 2021 and referred to the Committee on Agriculture. On Jan. 21, 2021, this bill was withdrawn from the Committee on Agriculture and referred to the Committee on Federal and State Affairs.

On March 1, 2021, the Committee on Federal and State Affairs amended the bill and recommended that HB2025 be passed as amended.

HB2089

This is a substitute bill that would permit school districts to provide firearm safety education programs but require that they be in conformance with two specific programs.

On March 15, 2021, the Committee on Federal and State Affairs recommended that a substitute bill for HB2089 be passed. On March 18, 2021, the House passed Substitute for HB2089 in a 75-47 vote.

This bill was introduced to the Senate on March 18, 2021 and referred to the Committee on Federal and State Affairs on March 19, 2021.

This bill would require KDWPT to administer the transfer of regular landowner or tenant hunt-on-your-own-land white-tailed deer permits from the original recipient to a nonresident.

The initial loss of the lifetime license revenue would be significant, but it would be compounded annually because the Department would not be able to count those licenses for Wildlife and Sport Fish Restoration (WSFR) funds, which are based, in part, on the the number of individual hunters and anglers who purchase a license in a given year.
