## **Position Announcement**

Kansas Department of Wildlife, Parks and Tourism

### **2-4 Summer Interns/Seasonal Positions – Topeka Region 2 Office, Perry WA/Atchison SFL**

Have 2-4 temporary positions (999 hours max.) available for State Fishing Lake Maintenance, directly supervised by Dustin Mengarelli, Public Lands Regional Supervisor. These positions are for the 2021 season. The individuals will be primarily involved in State Fishing Lake Maintenance but could also include all facets of Wildlife and Parks public lands operations. Job duties include but not limited to; mowing, weed eating, trash pickup, fire-ring maintenance, bathroom cleaning, and chemical spraying. Other job duties could include: prescribed burning, tree removal, timber stand improvement, sign maintenance, control of noxious weeds and other undesired vegetation. Operations of a variety of equipment including mowers, weed eaters, sprayers, hand tools, UTV's, trucks and trailers. Other equipment could including tractors and agricultural implements (discing, mowing, planting food plots, etc.) and skid steer loaders. Incumbents will work a maximum of 40 hours per week. Positions will run through the spring and summer months.

**BENEFITS:** Hourly wage \$11.25 – \$15.50 per hour depending on experience, education, and abilities. Normal work week will be Monday-Friday, 40 hours maximum per week, 999 hours per calendar year. No paid holidays.

**MINIMUM REQUIREMENTS:** Must be physically fit and able to perform demanding tasks in a variety of outdoor setting and weather conditions. Required to be at least 18 years of age with a valid driver's license. A preference will be given to students working toward a degree in Wildlife and/or Fisheries Ecology and Management, Park/Resource Management, Wildlife Outdoor Enterprise or Criminal Justice (with interest in becoming a Game Warden).
