

## **Seasonal Fisheries Technician**

A seasonal position in the Fisheries Division is available at Woodson State Fishing Lake near Toronto, KS. The position will be directly supervised by Justin Morrison, District Fisheries Biologist. Preferred starting date is May 2<sup>nd</sup> with the possibility of employment lasting through November. The hours can be variable, but usually do not exceed 40 hours/week (999 hour maximum per year).

**Job Duties** include but are not limited to:

- Assisting the Fisheries Biologist with standardized sampling methods utilizing a variety of gears and equipment including an electrofishing boat, gill nets, and fyke nets.
- Assist with the maintenance, feeding, and harvest of the Woodson Rearing Pond.
- Assisting with the construction of fish habitat structures made from natural or artificial materials.
- Fish stockings
- Fisheries equipment repair and maintenance
- Other duties as assigned

**Benefits:** Hourly wage range \$10.75 - \$13.50, depending on experience.

**Minimum Requirements:** Must be a minimum of 18 years old, have a valid driver's license; able to work with minimum supervision; must be able to communicate in an effective manner with fellow co-workers and the public in all conditions; be in good physical condition and able to withstand physically demanding work that requires lifting heavy objects repeatedly; demonstrate responsible behavior and attention to detail. Familiarity with operation of power tools, hand tools, boats, and trucks is preferred.
