Monitoring harvest is an integral part of deer management for the Kansas Department of Wildlife, Parks, and Tourism (KDWPT). Harvest data in conjunction with population monitoring directs more effective harvest goals and regulations. Additionally, hunter activity information increases the ability of deer managers to refine opportunities and adjust harvest goals as part of maintaining sustainable deer populations. KDWPT utilizes a post-season harvest survey to gather this data. This survey is administered once deer permit sales are summarized, so that a sample that is proportional to each permit type maybe randomly drawn. The survey period is approximately 21 days long. Participants selected for participation by email receive an initial email, and two follow up emails at one-week intervals if they have not completed the survey. Participants selected for participation by postcard receive one postcard at the beginning of the open survey period. Data summary and analysis was completed using the statistical program R.

The following summary includes information and is organized in the following order: permit sales, deer harvest by species, age, and sex, harvest by weapon type, hunter use, and deer kill on private, public and WIHA properties, season participation, hunter days afield, date of harvest, hunter satisfaction, and a summary of the special section questions. Additionally, an appendix (Appendix 1) includes estimated deer harvest by species, age, and sex for each of the 19 Deer Management Units in Kansas. An additional separate document (2020-21 Deer Harvest Survey Supplementary Material – Hunter Comments) contains all comments received through the survey as they were written, except that personal identifying information (e.g., names, phone numbers, etc.) are redacted.

This is a summary of the survey data compiled from responses of hunters completing the postseason survey. The accuracy of this summary relies on the accuracy of information provided by participants. When possible, survey responses with information that was not valid were corrected (e.g., a hunter marks one deer harvested but classifies two and the information in each classification is the same, one classification would be dropped) or removed from the dataset.

Permit Sales and Survey Sample Summary




Figure 1. Deer permit sales 2010 to present. Resident sales (orange) have declined the last three years. Non-resident sales have remained steady since most non-resident permits are limited availability through the random draw, variation in non-resident permits is typically due to changes in the number of hunt-own-land or white-tail antlerless only permits sold.

The total deer permits sold in Kansas for the 2020-21 deer season was 182,821 (Fig. 1), which is an increase of 4.71% from 2019-20 and 0.94% above the five-year average. This was the first year since 2014 that year over year permit sales increased. Most of the increases were in resident over-the-counter permits. Non-resident permit sales have been relatively steady since most non-resident permits are limited availability with quotas, but slight variation occurs with Hunt-Own-Land permits.

Deer hunters in Kansas are limited to one permit allowing the take of an antlered deer (the buck permit; all permits allowing an antlered deer to be taken are either sex permits) and must purchase this permit before they may purchase antlerless-only permits unless they purchase antlerless only permits after December 30. During the 2020-21 deer season, hunters purchased 110,411 buck permits. A total sample size of 40,000 was drawn from hunters purchasing buck permits to receive the Kansas Deer Harvest Survey. The 40,000 hunters are sampled in proportion to the number of each type of permit sold. Thirty-two thousand hunters receive an email invitation with a weblink to participate in the survey. Eight thousand hunters are mailed a postcard with a weblink they may use to participate in the survey. Additionally, 3,500 bowhunters receive a paper form of the Deer Harvest Survey as part of participating in the Bowhunter Observation Diary, which they mail mail-in or follow the included weblink. All surveys include a hunter's KDWPT number to prevent duplicate surveys from being included as

part of the results. The actual number of email invitations sent in the 2020-21 post-season was 33,122, due to incorrect emails, closed emails, etc. A total of 12,775 usable responses were received, made up of 10,474 responses to email invitations, 1,838 responses to postcards, and 463 responses from the Bowhunter form. Recent changes in international privacy law prevented surveying youth hunters under 16, therefore all youth data were included in the equivalent general resident category. All nonresident draw permits were issued through the draw. No leftover permits were available for the 2020-21 deer seasons.

Statewide Deer Harvest




Figure 2. Kansas statewide deer harvest 1965 to present. Greatest harvest occurred in 2000 (111,159) lowest harvest occurred in 1965 (1,504). The first modern deer hunting season in Kansas was held in 1965.

The 2020-21 statewide deer harvest of 83,126 an increase of 5,226 deer from the previous season's harvest. Harvest in 2020-21 was 2.71% above the three-year harvest average of 80,931 and was 1.75% above the five-year harvest average of 81,700 (Fig. 2). The 2020-21 deer harvest was the highest since 2016 and was the 12th highest harvest in Kansas since modern deer hunting seasons began in 1965; the highest was the 2000 season, when 111,159 deer were harvested.

Resident hunters hunted at a slightly higher rate (95.0%) than non-resident hunters (93.0%), although 94.1% of all hunters who purchased a deer permit spent time afield. Residents had a slightly higher rate of successfully harvesting a deer than nonresidents. KDWPT again, for the third consecutive season, did not offer Either Species Antlerless Only permits to limit female mule deer harvest. The total mule deer harvest (1,772) was slightly higher than the previous season (1,732) and the number of antlerless mule deer harvested (167) increased from 2019-20 (112) but was still lower than in 2018-19 (214). Mule deer harvest made up 2.1% of the total deer harvest, which was similar to the 2019-20 season (47.7%). Deer harvest estimates by species, sex, and age for each Deer Management Unit are included in Appendix 1.

Statewide Harvest by Weapon Category




Figure 3. Proportion of harvest by weapon category and proportion of harvest by sub-category within weapon category. The proportion of deer harvest by archery methods has increased while the proportion of harvest by firearms methods has decreased. The proportion of deer harvest by weapon sub-category has remained steady within the weapon categories, except for crossbow and compound bow sub-categories in the archery harvest category.

A greater proportion of deer were harvested by centerfire firearms (Table 2) than any other, but compound bows were the next most popular weapon choice. Pistols were the least used method (0.21%) of harvest although shotguns with slugs (0.37%), recurve or longbow (0.62%) and traditional muzzleloaders (0.56%) were also little used. As a group, muzzleloader hunters killed only 3.0% of the overall deer harvest. In 2019-20 archery methods were used to harvest 39.9% of all deer harvested, down from 40.5% in 2018-19. The proportion of the archery harvest by crossbows increased by 5.6%, and accounts for 34.0% of deer harvested by archery methods and 13.6% of the overall deer harvest (Fig.3).

Hunter Use and Deer Harvest on Public, Private, and WIHA Properties

Kansas has multiple types of land available for hunters to utilize. Most land in Kansas is under private ownership. A portion of privately-owned land is open to public hunting through the Walk-In Hunting Access Program (WIHA). During the 2019-20 deer season 1,180,000 acres of WIHA was available for public hunting. There were also approximately 390,000 acres of state and federal land, much of which is specifically managed to maximize wildlife resources. The value of these publicly accessible properties to deer hunters in Kansas can be seen by the proportion of the total deer harvest that comes from those properties. Public land makes up 0.74% of land in Kansas, yet 5.84% of the total estimated deer harvest occurs on those properties (Table 3). The proportion of deer harvest on WIHA properties is 3.88%, but WIHA properties account for 2.25% of Kansas. Private property not in WIHA accounts for the remaining 97.01% of land and 90.28% of deer harvest, respectively.

Hunter Participation by Season

During the 2020-21 deer seasons, only the muzzleloader and archery seasons had a greater than expected proportion of participation by non-residents. Of the three major seasons (muzzleloader, archery, firearms), firearms season has the greatest proportion of participation by Kansas residents at 87.6%. Seasons that limited harvest to antlerless deer, are proportionally more heavily participated in by residents. While most antlerless seasons are specific to deer management units and occur after seasons allowing antlered deer harvest; the proportion of participation in the Pre-rut season, which is available statewide, was 99.3% Kansas resident and only 0.7% non-resident. The same applies to seasons that limit participation to a specific segment of the hunter population like the designated persons season (Youth/Disabled Season) at 91.8% resident participation. A slightly greater than expected proportion of residents indicated that they did not participate in any season and did not hunt at all.

Hunter Days Afield

During the 2020-21 deer seasons hunters in Kansas spent over 1.26 million days hunting deer (Table 5). Not including antlerless permits, residents averaged 12.7 days hunted per permit purchased, while non-residents averaged 7.5 days hunted per permit purchased. General resident and youth hunters who held a statewide archery permit hunted the second most days per permit at an average 16.9 days, behind resident landowner/tenants holding a statewide archery permit hunted second most averaging 17.0 days per permit. Resident landowner/tenants hunted the fewest average days per permit at 4.0 days with a Muzzleloader permit. Among non-residents the most days hunted were by hunters using a Hunt-Own-Land permit or Archery permit at an average of 8.9 days per permit, while non-residents with a whitetail either sex permit hunted on average of only 4.8 days per permit.




Figure 4. Deer Harvest by Date. Harvest is split by permit type used as either the Either Sex permit (Buck permit) and Whitetail antlerless only permit. Dates (in Year/Month/Day format) labeled on the x-axis are Saturdays during the 2020-21 season. More deer (21.5%) were harvested on Saturdays than any other day of the week, while Tuesdays have the least amount of harvest (8.25%). January antlerless seasons accounted for 12.2% of the deer harvest, the 12-day firearms season for 45.3%, and only 1.0% occurred during the 3-day October pre-rut antlerless season.

Hunter Satisfaction

Satisfaction of Kansas deer hunters was largely tied to whether they harvested a deer (Table 6). A greater number of hunters that harvested a deer also completed the satisfaction portion of the survey. In general, hunters harvesting a deer displayed greater satisfaction rates than those that did not. Non-residents were also likely to display greater satisfaction than residents.

Special Section Wounding Loss and Tracking Dog Use

As part of the 2020-21 Kansas Deer Harvest Survey, we asked hunters to report the number of deer they hit but did not recover, the number of times they utilized tracking dogs to pursue wounded deer and how many deer they recovered that they would not have found without utilizing a tracking dog. Some wounded deer may recover from being wounded by hunters and hunters may have reported some deer they shot at as wounded although the deer may not actually have been wounded, further confounding this would be deer that were not reported as wounded but actually were wounded which could not be estimated with this data. Since it is impossible to know how many deer were inaccurately reported, or not reported, as wounded or survived and recovered, the estimates reported here do not necessarily mean that all deer reported as wounded were removed from the population.

Estimates indicate that a substantial number of deer are wounded by hunters but not recovered (Fig. 7) and adding the total wounding loss to the total harvest would increase the total harvest by 10.5%. Total white-tailed deer wounding loss equates to 10.6% of the overall whitetailed deer harvest, while wounding loss only equates to 7.6% of the total harvest for mule deer. There may be multiple possible reasons that wounding loss may be substantial and greater for some age and sex classes of deer, but here these are no more than speculation as we did not attempt to collect data to verify them. While hunters generally take ethical shots, conditions while hunting can lower the probability of a successful shot, and hunters may risk taking shot opportunities with lower probabilities of success at deer they place higher value on such as adult bucks. We note also that hunters with less experience of hunting or shooting may be less successful with shot placement or in finding deer they have hit and conditions during the 2020-21 season with more people utilizing the outdoors due to SARS-CoV-2 (COVID-19) may have increased the number of less experienced hunters afield. Since hunters were asked about deer they hit but did not recover, deer they value less may have been reported at lesser rates if hunters expended less effort confirming a hit compared to higher value deer (e.g. search less for a fawn versus more for an adult buck).

White-tailed deer adult buck wounding loss equates to 12.6% of the total white-tailed deer adult buck harvest. Adult bucks also make up 62.6% of the white-tailed deer estimated wounding loss but only 52.6% of the actual white-tailed deer harvest. All other ages and sex classes of white-tailed deer made up a lower proportion of wounding loss than the equivalent age and sex class proportion of the total harvest. Mule deer wounding loss equates to a lower proportion (7.6%) of mule deer harvest than in white-tailed deer. Sample sizes for mule deer wounding loss were small and the resulting estimates have wide confidence intervals. Still wounding loss may have a greater impact on mule deer which tend to occur at low densities and have lower fecundity rates than white-tailed deer in Kansas. The adult antlerless mule deer wounding loss in mule deer, while adult antlerless mule deer harvest and 25% of the wounding loss in mule deer, while adult antlerless mule deer only make up 8.7% of mule deer harvest.

Wounding loss of deer might have been greater in Kansas but tracking dog use may have mitigated the potential loss by up to 27%. We estimated that hunters utilized tracking dogs in 4,561 (95% CI: 3,963 - 5,160) searches in Kansas during the 2020-21 season and that estimates from hunter reports indicated that 3,227 deer (95% CI: 2,850 - 3,604) would not have been found without a tracking dog. When hunters utilized tracking dogs, they successfully recovered a deer 70.8% of the time. Hunters are strongly encouraged to utilize a tracking dog if their initial search for a deer is unsuccessful.

Wounding loss can be more accurately included in deer management with these estimated rates. While the estimated wounding loss of deer in this analysis may not equate to the same number of deer removed from the deer herd, conservatively using it as the rate of deer lost from the population will allow more precision when assessing the effects of hunting on deer populations in Kansas. Tracking dogs also play an important role in recovering deer in Kansas which reduces wounding loss impacts; therefore, hunters are recommended to utilized them and support trainers that develop tracking dogs.




Appendix 1. KS Deer Harvest by Species, Sex, and Age for Each Deer Management Unit
